

### Directions to Northern Illinois Brace Club in Roscoe, Illinois

From I-39 South/I-90 East, go to Rockton Road (Exit #3). Go East on Rockton Road to County Line Road (second stop sign). Take County Line Road South to Elevator Road (first stop sign). Go West on Elevator Road .3 miles. NIBC will be on the North side of Elevator Road.

From I-43 go to Highway 140 (Exit #6). Go South on Highway 140. After about 5 miles Highway 140 curves at the State Line and becomes Highway 76. Continue for 4.5 miles to Hunter Road. Take Hunter Road to the West (right) for about 6 miles to NIBC on the North side of Elevator Road (Hunter Road becomes Elevator Road at the County Line .3 miles before NIBC).



**OUR SUGGESTED ROUTE FROM THE EAST TO BYPASS CHICAGO** is to take I-80 along the south side of Chicago until you are well past Chicago, then head north on I-355. YOU MUST EXIT I-355 at I-88 West or you will end up back on I-90! Take I-88 East to I-39, just a bit south of Rockford. When you get to Rockford you can follow our normal directions or trust your GPS.

This new route calculates as a half hour longer than routes through Chicago on the Skyway (I-90) or the I-294/I-290 bypass. With construction or traffic in Chicago- it could save you a couple of hours of travel time and a lot of stress. It is a VERY NICE ROUTE.

FYI – Coming from the East, I-80/I-90 are running together near Portage, Indiana. I-80 leaves I-90 and joins I-94 near mile marker 16. You pass into Illinois. I-80 leaves I-94 and joins I-294 near mile marker 161. Finally, I-80 leaves I-294 and runs alone near mile marker 155.

\*\*When traveling on I-80 West there might be a detour that sends you into Chicago on I-90, the Skyway, but just for a few miles. You will turn off on I-65 which goes south for just a couple of miles where they will once again turn you onto I-80.\*\*



### **OUR RULES & THINGS YOU REALLY WANT TO KNOW**

**AWARDS:** Ribbons or rosettes will be awarded for qualifiers in all tests. <u>No rosettes for EE qualifying performances at the discounted entry fee.</u>

**BARKING.** This is a residential area. The barking of dogs must be kept under control **at all times, including dogs in x-pens during the tests**. Winnebago County fines range from \$50-\$500 for nuisance barking complaints.

**CAMPING/PARKING:** Overnight camping is available at the grounds. \$20 per night for camping with water and electric hook-ups, \$15 per night with electric only and \$10 per night for overnight parking/camping in the parking lot or clubhouse. There is no charge for day parking. Please leave a walkway from the camping hook ups closest to Elevator Road, past the west side of the split rail fence, to the east door of the clubhouse. This walkway should be clear of tents, x-pens, tables, etc. for safety purposes. If this is not self-monitored, you may be requested to move your stuff from this area. For those staying on the grounds and in the clubhouse, quiet hours are from 11:00 p.m. to 7:00 a.m. During this time, please keep outside lights off, dogs quiet, and noise to a minimum.

CLUBHOUSE: No dogs allowed in the clubhouse.

**ELIGIBILITY:** Dogs must be six months of age or older and be registered with the American Kennel Club. Spayed and neutered dogs, dogs with Limited Registration, and dogs of an eligible breed that have been granted ILP (Indefinite Listing Privileges) are eligible to participate. The following breeds are classified as eligible to participate in earthdog tests: Dachshunds, Miniature Schnauzers, Miniature Pinschers and the following Terriers: Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Glen of Imaal, Parson Russell, Lakeland, Manchester, Miniature Bull, Norfolk, Norwich, Rat, Russell, Scottish, Sealyham, Silky, Skye, Smooth Fox, Welsh, West Highland White, Wire Fox and Yorkshire. Dogs that are blind and deaf shall not be eligible. Bitches in season shall not be eligible to enter the test. Entry fees paid for a bitch that comes in season shall not be refunded. A complete copy of the "Regulations for Earthdog Tests for Small Terriers and Dachshunds" can be obtained by contacting The American Kennel Club, 5580 Centerview Drive, Raleigh, NC 27606.

Introduction to Quarry (Intro) - Non-regular class. No pre-requisite. Open to all eligible dogs.

Junior Earthdog (JE) - Open to all eligible dogs.

Senior Earthdog (SE) - Open to all eligible dogs that have earned a Junior Earthdog title.

Master Earthdog (ME) - Open to all eligible dogs that have earned a Senior Earthdog title.

Endurance Earthdog (EE) - Any dog that has acquired a Master Earthdog title is eligible to earn an Endurance Earthdog title. In order to earn an Endurance Earthdog title, a dog must on five occasions pass both the Senior Earthdog test and the Master Earthdog test at the same event.

\*Regulations for Earthdog Tests for Small Terriers and Dachshunds Section 6. Dogs may enter only one regular class at an Earthdog test, except dogs which have earned a Master Earthdog Title may enter more than one regular class (Regular classes are classes from which the dogs may earn titles, i.e. JE, SE, ME). No further title certificates will be awarded.

ENTRY FEES: IQ (Non-Regular Class) - \$12.00; JE, SE, ME (Regular Classes) - \$20.00, Endurance Earthdog (SE/ME combined) \$36.00. No refund for EE entries that do not run in both classes. There is NO PRE-ENTRY DISCOUNT.

FOOD: No food will be provided by the Club.

**RUNNING GROUNDS:** Field trial practice for Dachshunds and Beagles is allowed after earthdog testing is complete on Saturday and Sunday. No dogs on the grounds after dark. Practice is limited to one dog at a time, per handler. Handlers must stay with their dogs and dogs must be under the control of the handler while on the grounds. Handlers who do not have their dogs under control will be asked to remove their dog(s) from the enclosure. OTHER BREEDS. Dogs may be walked on lead within the enclosure after testing is complete. No dogs on the grounds after dark. Dogs may not be turned loose inside the enclosure, except during testing.

**RUNNING ORDER:** Dogs will be run in the order that entries are received, except for Master which will be braced by random draw. The test committee may modify the running order to keep the event running smoothly.

WEATHER. Please bring weather appropriate gear - tests are run rain or shine.

**WITHDRAWN DOGS.** No refund of entry fees after a class has closed. The bracemate of a dog withdrawn from Master Earthdog will become the bracemate of the bye dog, or become a bye dog.
